

GAME ON! READY, SET, WIN! SWEEPSTAKES OFFICIAL RULES

- 1. PROMOTION PERIOD: The Game On! Ready, Set, Win! Sweepstakes ("Promotion") begins 12:00 AM (midnight) Mountain Time ("MT") on September 4, 2024 and ends 11:59 PM MT on December 8, 2024 (the "Promotion Period"). Plays are only available from 12:00 AM MT on September 4, 2024 until 11:59 PM MT on December 3, 2024 ("Purchase Period"). Plays must be redeemed by 11:59 PM MT on December 8, 2024. The Promotion consists of a series of random drawings which includes thirteen (13) weekly entry periods (each, a "Weekly Entry Period" or "Entry Period") and the Grand Prize Drawing ("Grand Prize Drawing"), as defined in the chart below in Rule #4.
- 2. Weekly Sweepstakes Mailed Entries and Grand Prize Sweepstakes Mailed entries will be collectively referred to herein as, "Mailed Entries" or "Entries" and singularly, "Mailed Entry" or "Entry").
